



CAPITAL INVESTMENTS

FQHC Expansion

This year, the Center celebrated the substantial completion of a major renovation project. The project reconfigured approximately 18,000 square feet of interior space at our main building so that it better absorbs the expansion of our federally qualified health center (FQHC) – the Pediatric and Family Health and Wellness Center. The renovation improves the flow of patient “traffic” throughout the facility and better accommodates the anticipated growth in our medical clinic.

Safety Enhancements and Risk Reduction

Except for 2000 square feet of space that was renovated in 2013 to accommodate the FQHC, our main building had not been substantially updated since its construction in 1979. As such, the renovation resolved major infrastructure concerns including 1) replacement of the leaking roofing system; 2) updating the obsolete sprinkler and plumbing systems; and 3) replacement of inadequate air conditioning units (currently underway). Restrooms were modernized and basic residential commodes were replaced with ones intended for commercial use.

Continuity Planning and Emergency Management

The purchase and installation of a Generator will fully power the Center's headquarters building and permit the Center to remain operational in the event of a power outage. The Center also purchased a vaccine storage refrigerator, satellite phones with cases, laptops, and a fireproof filing cabinet.





GRANTS, AWARDS & RECOGNITION

CFCE Receives HRSA American Rescue Act Grant

On March 24, 2021, CFCE's Pediatric and Family Health and Wellness Center (PFHWC) received a \$1.3 million award from the Health Resources and Services Administration (HRSA), a Federal agency under the U.S. Department of Health and Human Services. For a two-year period, CFCE will use these funds to: 1) promote, distribute, administer, and track COVID-19 vaccines; 2) detect, diagnose, trace, and monitor COVID-19 infections; 3) purchase equipment and supplies to conduct mobile testing or vaccinations for COVID-19; 4) modify, enhance, and expand health care services and infrastructure; and 5) conduct community outreach and education activities related to COVID-19.

CFCE Receives HRSA Health Center Quality Improvement Awards

The Community Health Quality Recognition (CHQR) badges recognize Health Center Program awardees that have made notable quality improvement achievements in the areas of access, quality, health equity, and health information technology. CFCE's PFHWC was one of 43 health



centers in the nation to receive an Advancing Health Information Technology for Quality award, one of 40 to receive a Patient Centered Medical Home Recognition award, one of 28 to receive a Clinical Quality Improver award, and one of just 13 health centers in the nation to receive an Access Enhancer award. All totalled, CFCE received \$68,303 for improving and advancing healthcare access and services during this fiscal year.

Florida Network of Youth & Family Services Recognizes CFCE for Innovative Approaches During Pandemic

CFCE's Children in Need of Services/Families in Need of Services (CINS/FINS) Program serves both male and female youth up to 17 years of age who are locked out, runaway, ungovernable and/or truant, homeless, abused, neglected, or at-risk.

Despite all of the pandemic-related challenges, the CINS/FINS Program saw growth in its numbers by remaining open throughout the pandemic, continuing intakes and providing services via FaceTime, mailing packages, and delivering them with limited face-to-face contact (exercising social distance and utilization of PPE supplies).

In response to the ongoing COVID-19 pandemic, CFCE has continued to provide community-based care services to children and families throughout Miami-Dade County. CFCE provided 39,600 telehealth visits to reach patients safely and meet their needs and has been at the forefront, administering over 200 tests and 1500 vaccines to patients, residents and provides.


